ORDER

Provisional affiliation was granted for starting self financing B.Ed programme at Bhavan's Ramakrishnan Institute of Teacher Education (Unaided), Ramanattukara, Kozhikode during the academic year 2004-05 with an intake of 100 students, vide the University Order read as first above.

- 2. National Council for Teacher Education, after adoption of the new Regulations 2014, granted fresh recognition to the institution for conducting B. Ed of two-year duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16 vide the order read as second above.
- 3. As per the University Order read as third above, permission has been granted to consider the applications received from the training colleges, at the beginning of each academic year (from 2017-18 onwards) as in the case of other courses and grant Continuation of Provisional Affiliation, without insisting orders for extension of approval from the NCTE each year.

- 4. Accordingly, Continuation of Provisional Affiliation to the self financing B.Ed programme for the academic year 2019-20 was granted with a total intake of 100 students, vide the University Orders read as fourth above.
- 5. Vide the paper read as fifth above, the Principal, Bhavan's Ramakrishnan Institute of Teacher Education (Unaided), Ramanattukara, Kozhikode has submitted the request for Continuation of Provisional Affiliation to the BEd programme for the academic year 2020-21, after remitting an amount of ₹143325/- (Rupees one lakh forty three thousand three hundred and twenty five only) via SBI E chalan No. 192241447 dated 19.12.2019 towards administration (₹88200/-) and affiliation (₹55125/-) fee. But Principal has not submitted renewal of NOC from Govt. which is mandatory for granting Continuation of Provisional Affiliation as per the University order read as sixth above. The Principal was requested to submit renewal of NOC from Govt. vide paper read as seventh above.
- 6. Principal has claimed, vide paper read as eighth above, the non requirement of renewal of NOC by producing the judgement dated 31.03.2006 issued by the Supreme Court of India in connection with the non requirement on NOC from the Govt. for starting a B.Ed college, judgement was issued on the ground of rejection of NOC by the State of Maharashtra to start a new B.Ed college during 2005-06.
- 7. Meantime, vide paper read as ninth above, the Principal, Bhavan's Ramakrishnan Institute of Teacher Education (Unaided), Ramanattukara, Kozhikode has submitted the request for Continuation of Provisional Affiliation to the BEd programme for the academic year 2021-22, after remitting an amount of ₹143325/- (Rupees one lakh forty three thousand three hundred and twenty five only)) via SBI E chalan No. 202238971 dated 10.12.2020 towards administration (₹88200/-) and affiliation [₹55125/- (11025 X5)] fee.
- 8.The Legal opinion of the University Standing Counsel on the matter of insisting renewal of NOC from Govt. has been placed before the Syndicate in its meeting held on 27.10.2020 and resolved vide item no.2020.888* to place the matter before the Standing Committee of Syndicate on Legal Affairs and Sports. The decision of the Syndicate was implemented vide University Order read as tenth above. The suggestions of Standing Committee of Syndicate on Legal Affairs and Sports has been considered by the Syndicate held on 22.09.2021 vide item no.2021.783 and resolved to place the whole matter in CDC Monitoring Committee. Subsequently, CDC Monitoring Committee recommended that the College shall submit renewal of NOC from Govt. up to the Academic year 2021-22 and the recommendations of CDC Monitoring Committee was approved by the Syndicate on 15.02.2022 vide item no.2022.111*.
- 9. In compliance to the Syndicate decision, Principal was directed to submit Renewal of NOC from Govt. up to the academic year 2021-22 vide paper read eleventh above and Principal, vide paper read as twelfth above, has submitted the documents to the effect of having applied for renewal of NOC from Govt. till the academic year 2022-23.
- 10. Renewal of NOC from Govt. up to the Academic year 2020-21 was submitted by the Principal, vide paper read as thirteenth above.
- 11. Considering the matter, sanction has been accorded by the Vice Chancellor, on 04.07.2022, for granting Continuation of Provisional Affiliation to the self financing B.Ed programme at Bhavan's Ramakrishnan Institute of Teacher Education (Unaided), Ramanattukara, Kozhikode for the academic year 2020-21 and Continuation of provisional affiliation to self financing B.Ed programme for the academic year 2021-22, on conditional basis, subject to the submission of renewal of NOC for Academic Year 2021-22.
- 12. Continuation of Provisional Affiliation is, therefore, granted to the self financing B.Ed.

programme, at Bhavan's Ramakrishnan Institute of Teacher Education (Unaided), Ramanattukara, Kozhikode, for the academic year 2020-21 and Continuation of provisional affiliation to self financing B.Ed programme for the academic year 2021-22, on conditional basis, subject to the submission of renewal of NOC from Govt.for Academic Year 2021-22, as detailed below, subject to the conditions mentioned thereunder

- 13. Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled.
- 14. In the light of the directions of the Supreme Court of India in Writ Petition (C) 656/1998, the institution shall take stringent measures for prevention of ragging in any form. In case of failure to prevent such instance of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.
- 15. The conduct of University examinations of any sort including that of SDE examinations is compulsory and binding on all colleges affiliated to the University of Calicut.
- 16. Affiliation granted is strictly provisional and only up to the academic year 2021-22. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University.
- 17. The Controller of Examinations shall ensure that examinations are not conducted in those colleges which do not have valid affiliation order.
- 18. Admission to the next academic year shall be made only after obtaining prior permission from the University.

Orders are issued accordingly.
