## **ORDER**

Provisional affiliation was granted for starting self financing B.Ed programme at Bhavan's Ramakrishnan Institute of Teacher Education (Un-Aided), Ramanattukara, Kozhikode during the academic year 2004-05 with an intake of 100 students, vide the University Order read as first.

- 2. National Council for Teacher Education, after adoption of the new Regulations 2014, granted fresh recognition to the institution for conducting B. Ed programme of two-year duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16 vide the order read as second.
- 3. As per the University Order read as third, permission has been granted to consider the applications received from training colleges, at the beginning of each academic year (from 2017-18 onwards) as in the case of other programmes and to grant Continuation of Provisional Affiliation, without insisting orders for extension of approval from the NCTE in each year.
- 4. Revised permanent seat distribution with effect from 2020-21 among different optional subjects in the B.Ed programme at various affiliated Training colleges was granted vide University Order read as fifth.
- 5. Continuation of Provisional Affiliation to the B.Ed programme for the academic year 2022-23 was granted with a total intake of 100 students, on conditional basis, subject to the submission of renewal of NOC from Govt. for the academic year 2022-23, vide the University Orders read as eighth.
- 6. Vide paper read as tenth, the Principal has submitted the request for Continuation of Provisional Affiliation to the B.Ed programme for the academic year 2023-24, after remitting ₹1,43,325/- (Rupees One lakh forty three thousand three hundred and twenty five only)) via SBI E chalan No.222912027 dated

28.12.2022 towards administration and affiliation fee. Principal has also submitted request for rearrangement of seats among optional subjects in .BEd. Programme for 2023 admission (2023-25 batch), vide paper read as eleventh, after remitting ₹15750/- (Rupees Fifteen thousand seven hundred fifty only) vide challan no. 232411080 dated 11.09.2023 and 232413172 dated 12.09.2023 towards fee for rearrangement. The Principal has also submitted renewal of NOC from the Govt. for the academic Year 2022-23 vide paper read as ninth.

- 7. Re-arrangement of seats was permitted for optional subjects in the B.Ed. programmes vide University orders read as fourth, sixth and seventh.
- 8. Considering the matter, sanction has been accorded by the Vice Chancellor for granting Continuation of Provisional Affiliation to the self financing B.Ed programme at Bhavan's Ramakrishnan Institute of Teacher Education (Un-Aided), Ramanattukara, Kozhikode for the academic year 2023-24, on conditional basis subject to the submission of renewal of NOC from Govt. for the academic year 2023-24, along with rearrangement of seats in optional subjects in B.Ed programme for 2023 admission (2023-25 batch) as detailed below and to absolutise the University Order read as eighth as the Principal has submitted the renewal of NOC from the Govt., for the academic year 2022-23 vide paper read as ninth above.
