<u>ORDER</u>

Provisional affiliation was granted for starting self financing B.Ed programme at Bhavan's Ramakrishnan Institute of Teacher Education, Ramanattukara, Kozhikode during the academic year 2004-05 with an intake of 100 students, vide the University Order read as first.

2. National Council for Teacher Education, after adoption of the new Regulations 2014, granted fresh recognition to the institution for conducting B. Ed programme of two-year duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16 vide the order read as second.

3. As per the University Order read as third, permission has been granted to consider the applications received from training colleges and to grant Continuation of Provisional Affiliation, without insisting orders for extension of approval from the NCTE in each year.

4. Revised permanent seat distribution with effect from 2020-21 among optional subjects of the B.Ed programme was granted vide University Order read as fourth.

5. Continuation of Provisional Affiliation to the B.Ed programme for the academic year 2023 - 24 was granted with a total intake of 100 students, on conditional basis, subject to the submission of renewal of NOC from Govt. for the academic year 2023-24, vide the University Orders read as fifth.

6. Vide paper read as seventh, the Principal has submitted the request for Continuation of Provisional Affiliation to the B.Ed programme for the academic year 2024-25. The Principal has also submitted renewed of NOC for the academic Year 2023-24 vide paper read as sixth.

7. Considering the matter, sanction has been accorded by the Vice Chancellor

(i) for granting Continuation of Provisional Affiliation to the self financing B.Ed programme at Bhavan's Ramakrishnan Institute of Teacher Education, Ramanattukara, Kozhikode for the academic year 2024-25, on conditional basis subject to the submission of renewed NOC from Govt. for the academic year 2024-25, as detailed below ,with direction to strictly adhere to the qualifications prescribed by the NCTE and in compliance to the provisions under Act 13 of 2021 Kerala Self Financing colleges

- 8. Orders are issued accordingly, subject to the following conditions.
 - The Principal shall strictly follow the syllabi available in the University website www.uoc.ac.in.
 - Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time.
 - In the light of the directions of the Supreme Court of India in WP (C) 656/1998, the institution shall take stringent measures for prevention of ragging in any form.
 - Affiliation granted is strictly provisional and only for the academic year 2024-25. The college has to apply for CPA for the ensuing years remitting the fee fixed by the University, along with the extension of approval orders, if any, from the apex bodies concerned.
 - The Controller of Examinations shall ensure that examinations are not conducted in those colleges which do not have valid continuation of provisional affiliation orders.
 - The conduct of University Examinations of any sort including that of the SDE Examinations is compulsory and binding on all colleges affiliated to the University of Calicut.
 - The college is liable to comply with the general conditions stipulated in the renewed NOC from the Govt. of Kerala.
 - Admission to the next academic year shall be made only after obtaining prior permission from the University.
 - Violation of any of the above will lead to the cancellation of affiliation.
